Chris is passionate about making a positive difference to people's lives and giving back to his community through initiatives such as the speakers in schools program.

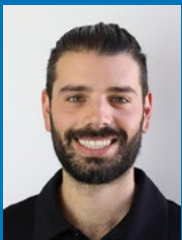


Jing Fang Executive Finance, Transformation and Governance
